
9 Tips for Transitioning to the NEW ASQ:SE-2™



Plan to screen more infants using ASQ:SE-2. ASQ:SE-2 now includes a 2 month questionnaire, so you can start screening children as young as 1 month of age.

Be sure to adjust a child's age for prematurity when selecting an ASQ:SE-2 questionnaire. You'll adjust if a child was born 3 or more weeks premature and is less than 2 years old.

→ Use the free ASQ website calculator or ASQ Calculator app to quickly and easily choose the right questionnaire.



Know when to adjust the ASQ:SE-2 score. In most cases, you won't have to adjust the score at all, but here are the key points to remember:

- If a questionnaire has 1 or 2 items missing, no score adjustment is needed.
- If 3 items are missing AND the child's total score is within 5 points of the cutoff score or the monitoring zone, calculate an adjusted score.
- If 4 or more items are missing, don't score the questionnaire. Follow up with the parent to get additional responses.

Learn how to use the new monitoring zone for ASQ:SE-2. The *monitoring zone* helps you monitor children who score close to the cutoff but not in the referral zone. You may refer right away, rescreen, provide information and resources, or choose another option. When girls score in the monitoring zone, you should strongly consider a referral for further assessment.

Make the most of ASQ:SE-2's new parent engagement materials. *Encourage parent involvement* by using the What is ASQ:SE-2? handout, the social-emotional activity sheets and guidelines, and the Parent Conference Sheet.

Review how ASQ:SE-2 is scored. Are you getting correct results? Take advantage of ASQ:SE-2's *new design features that help with* accurate scoring. For example, now there's a place to record the score for each item and a reminder to add 5 points for every item marked as a concern.

Use the new ASQ:SE-2 Item Response Sheets. You can record questionnaire responses here if you return completed pages to parents, and share these sheets easily with pediatricians or other providers. Item Response Sheets can be printed right from the questionnaire CD-ROMs.

Track your ASQ:SE-2 follow-up. The ASQ:SE-2 Information Summary sheet now has a place to record follow-up actions after screening. Use this section to help make sure any necessary next steps occur.
