This is a parent completed tool; it is not for the teachers to complete. Teachers are providing the tool to the parents either by paper or through Family Access in the ASQ Online system. Teachers may provide assistance if needed. Please remember that teachers are not to screen the children.



What are we (as educators) doing with the results?




Data collected at the state level will be the number of children who entered Kindergarten developmentally ready. This data will be used to measure the Kindergarten Readiness of children statewide and inform policy decisions about early learning resources and systems.

ASQ Online will provide rich data that can be used locally to help schools:

- **Design environment and instruction to meet the needs of their incoming Kindergartners;**
- **Support aligned teaching practice and program planning;**
- **Support individualized instruction;**
- **Support teacher–parent partnerships;**
- **Screen for potential learning difficulties.**

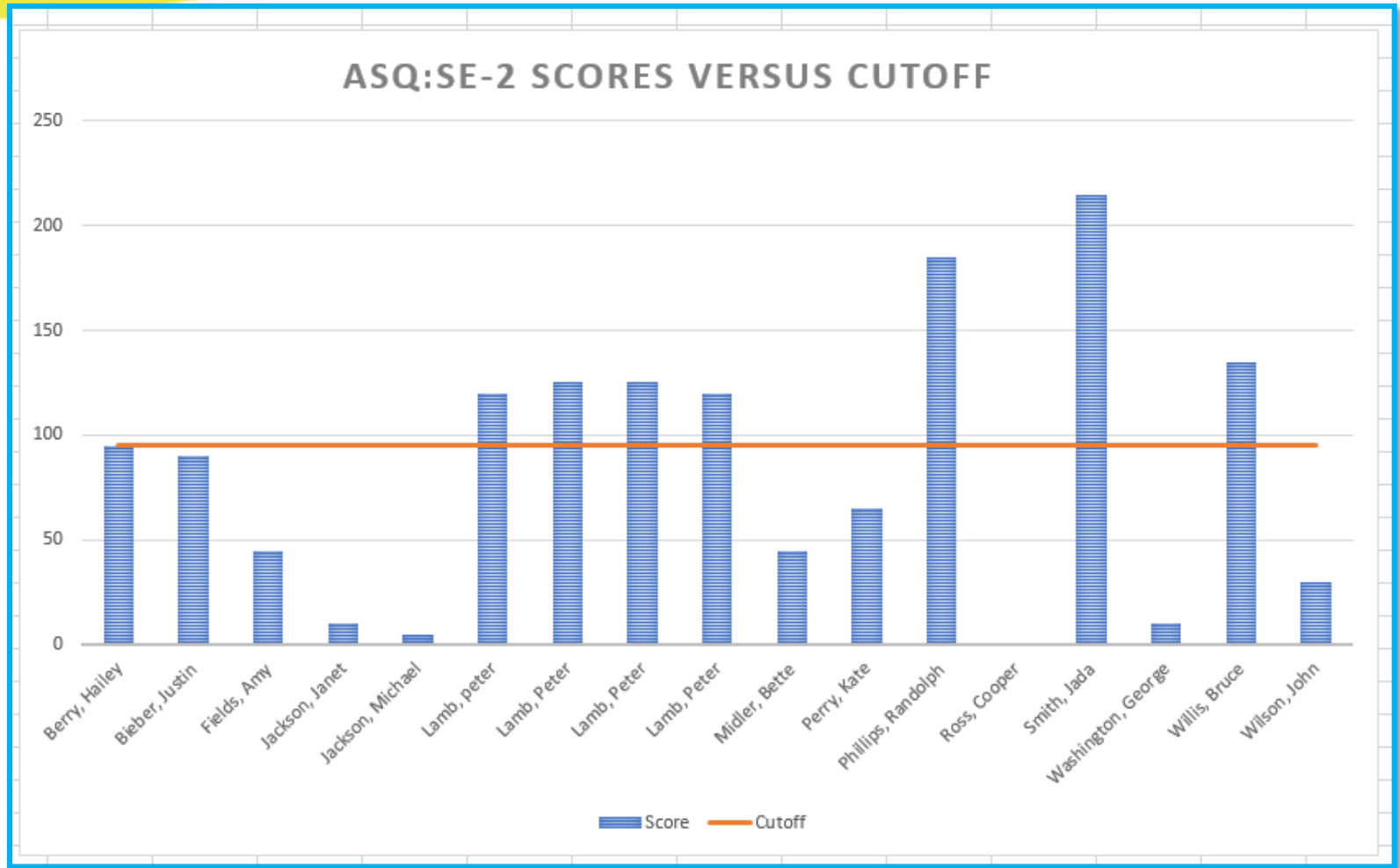


What type of reports do I have access to?

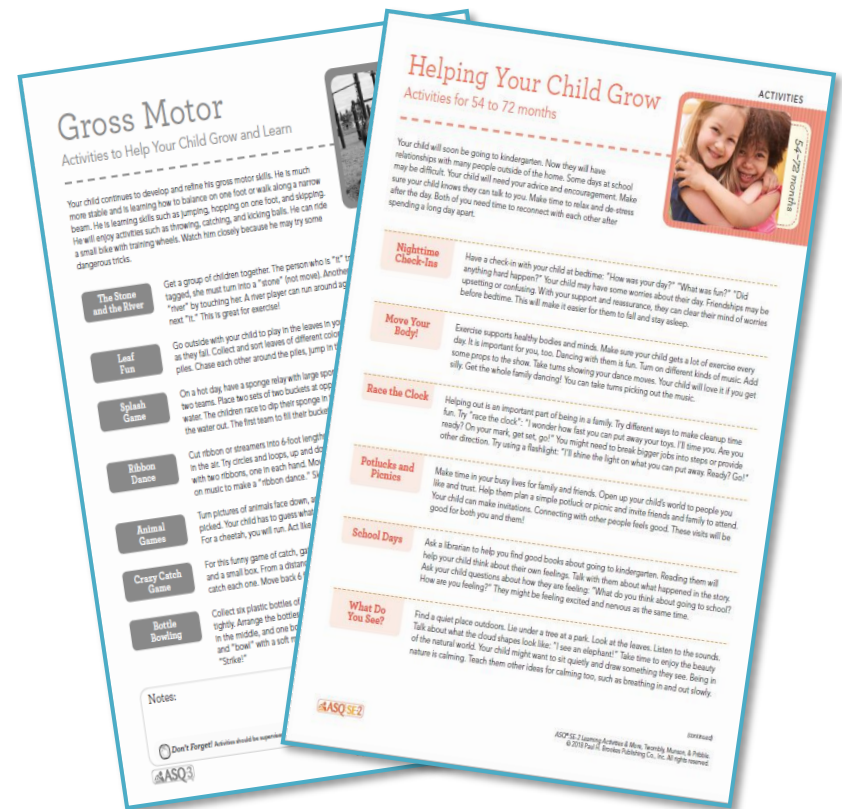
