An Inside Look at ASQ Online Reporting!



ASQ® Pro and ASQ® Enterprise enable users to generate a wide selection of reports for individual children, individual programs, and/or groups of children across multiple programs in an ASQ® Online account. The report generation page includes a number of search options for customizing reports (e.g., interval, date range). Many of the reports offer users the ability to include custom child profile fields and all child profile fields. Reports can be downloaded as PDF or CSV files (editable in Excel) or previewed in your browser.

ASQ Online has four pre-defined roles: Account Administrator (ASQ Enterprise accounts only), Program Administrator, Provider, and Reviewer. Account Administrators can view data for all of the programs in their account. Program Administrators in an ASQ Enterprise account can view data for their program; Program Administrators in an ASQ Pro account can view data for their account. Providers can view data for the children assigned to them. Reviewers can view data for the programs and children for which they have been provided access.
